

## SPECIAL NASHOBA SUMMER ADVENTURES

In addition to our many day and overnight hikes and canoe trips free of charge, we are pleased to continue to offer exciting trips for Nashoba campers in New England. The following are the available dates and fees for these trips. All groups will be limited to a small number of participants and Nashoba staff will accompany all campers in addition to program personnel.

**2 days and 1 night** of fun and adventure in The Forks, Maine with Camp Nashoba North and the Moxie Outdoor Adventure staff. On day one, after settling in, you will enjoy a canoe trip, picnic and swim on Lake Moxie. In the morning you will head off to raft the exciting class IV & V white water rapids of the Kennebec River. At night you will sleep in tents at Moxie's home base and enjoy the use of their outdoor facility. This trip is limited in size. Campers must be **12 years of age**, in good physical shape and be a Nashoba boater. Two trips will be offered and the fee is \$195.00, which is all inclusive. PLEASE NOTE: **Parents and campers must sign** the rafting release on the reverse side of this page.

**Casco Bay Islands & Historic Freeport.** Enjoy a day of land and sea. The day will be split into two parts; first spend the morning in beautiful Freeport, a coastal Maine village with over 100 upscale outlets, designer shops and it is also home to the world famous L.L. Bean store. The afternoon will be spent on the water, campers will be treated to a majestic boat tour of Casco Harbor seeing harbor seals, and learning more about the wildlife and the history of the area. This boat is exclusively for Nashoba campers. Offered twice this summer, once each session (no age requirement). The fee is \$95.00. This trip is limited in size, so sign up early! Campers will be required to wear a Nashoba t-shirt and stay with the group for the duration of the day. \$20.00 spending money will be given to each camper from the trip fee of \$95.00

Enrollment for these programs will be taken on a first come first serve basis via the postal service. Payment should be made in full upon registration. Your child's enrollment will represent your agreement to your child's participation in these activities, and acceptance of all the benefits and risks of such activities, and agree to release Camp Nashoba North, Inc from all claims resulting from the risks reasonably associated with these activities. **MOXIE OUTDOOR ADVENTURES**

I fully understand and acknowledge that: (a) risks and dangers exist in my child’s use of rafting, biking, kayaking, camping or canoeing equipment and my child’s participation in rafting, biking, kayaking, camping or canoeing activities; (b) my child’s participation in such activities and/or use of such equipment may result in injury or illness or death or damage to personal property (c) these risks and dangers may be caused by other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including, but not limited to, selection of trail or river route, water level, weather conditions, risks of falling out of the raft, kayak, or canoe, and such other risks, hazards and dangers that are integral to recreational activities that take place in the wilderness, outdoor or recreational environment; and (d) I hereby accept and assume all these risks and dangers.

I have been advised that my child must wear an approved personal flotation device at all times while on the water. I affirm that my child will not be under the influence of alcohol or controlled substance, and will not carry, use, or consume these substances before or during her/his scheduled activities. Any claims or dispute arising from my child’s participation in Moxie Outdoor Adventures, activities or use of North American Whitewater & Moxie Outdoor Adventures, equipment shall be venued in the Somerset County Supreme Court of the State of Maine.

My child is in good health and is at or above the minimum age stated in Moxie Outdoor Adventures & North American Whitewater advertising for each activity in which he/she will participate. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems, which will present any risk to his/her participation in the activities. I permit the use of any photos, slides, films, or sketches of him/her taken during the day’s activities for publicity, advertising, promotion, or other commercial purpose: The above agreement shall be binding on my heirs, successors, assigns, administrators and executors.
